On June 10, 2015, an undercover investigator with the Okaloosa County Sheriff's Office entered the business and purchased a thirty minute massage. This massage was conducted by the Defendant, who was later identified as Xiaohong Ren. After completing the massage, the undercover investigator inquired with Ren as to if any other services were available to "relieve stress." Ren repeatedly asked the undercover investigator what he wanted and he responded that he was looking for "stress relief" but never specified any sexual or lewd act. Ren then pointed towards the undercover investigator's genital area, with her hand and finger approximately four inches away from his person. Ren then lowered her voice and stated, "Do you want that?" She then motioned to the undercover investigator to lower his

prostitution occurring at Déjà vu Chinese Massage, located at 114 Palmetto Avenue #3, Destin, Florida.

During the month of May 2015, the Okaloosa County Sheriff's Office Narcotics Unit received information of

voice when speaking. The undercover investigator asked, "How much?" Ren then stated, "Forty dollars," and put four fingers up. The undercover investigator replied, "Forty dollars? Okay." The undercover investigator then attempted to retrieve the funds and she informed him to pay later.

The undercover investigator laid down on the massage table while Ren put a substance on her hands. She then immediately returned to the undercover investigator, stood at his left hip, and without prompting, immediately reached her left hand into the waistband of the undercover investigator's underwear and attempted to disrobe him.

Investigator Ben Lanier with the Florida Department of Health was also present during the operation and confirmed that Ren was not licensed through his department, as required by law, in any capacity.

This in violation of F.S.S. 456.065(d1) Unlicensed Practice of a Health Care Profession, F.S.S. 480.047(1a) Misrepresentation as Licensed Masseur, and F.S.S. 796.07(2e) Offering to Commit Prostitution and/or Lewdness, and did occur in Okaloosa County, Florida.
