[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 02-20-2016 your Affiant was dispatched to 1300 Miracle Strip Parkway, Fort Walton Beach, Okaloosa County, Florida, in reference to an attempted burglary in process.

On 02-20-2016 your Affiant made contact with Jonathan Berry (Defendant) at the aforementioned address. The defendant stated he was waiting for the manager who resides in unit 106 to give him a key to his mothers residence. Per Sheriffs Office Master Name Index, the defendant has a trespass warning for unit 106. Contact was made with the residents of unit 105 who stated the defendant tore the screen from their window. The window is located between unit 105 and 106.

During a search incident to arrest, Berry was found to be in possession of approximately twenty-eight (28) grams of suspected Heroin and two (2) syringes. Your Affiant noted that the suspected Heroin was packaged in a manner consistent with the distribution of controlled substances; e.g.: One (1) plastic bag contained approximately twenty-three (23) grams of suspected Heroin and fifty-three (53) jeweler's bags containing amount ranging from approximately one (1) gram to one-tenth (0.10) of a gram. Your Affiant field tested a portion of the suspected Heroin utilizing a presumptive field test kit and it rendered a positive response for heroin.

During a post Miranda interview, Berry claimed ownership and knowledge of the suspected Heroin and stated he had obtained it in Arizona from unnamed persons. Berry also stated that was a heroin user and claimed that the Heroin was for personal use.

Based on the above your Affiant has probable cause to believe that Jonathan Berry did violate Florida State Statutes 893.135.1c1: Trafficking in Heroin (approximately 28 grams); 893.147.1: Possession of Drug Paraphernalia; 810.08.2a trespassing. These violations occurred in Okaloosa County where your Affiant is a sworn Law Enforcement Officer.
