[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On December 6, 2016, the United States Marshal's Service Florida Regional Fugitive Task Force conducted a warrant service at 219 Cypress Street, Fort Walton Beach, Florida. The arrest warrant was issued for the Defendant, CHARLES BRENT GANT, by the North Little Rock Police Department located in Arkansas for the charge of Homicide-Willful Kill.

Upon being challenged by law enforcement personnel, CHARLES BRENT GANT, fled on foot and a footpursuit ensued. Your Affiant gave CHARLES BRENT GANT verbal commands to stop running without compliance. Your Affiant tackled CHARLES BRENT GANT in the backyard of an adjacent building and took him into custody.

CHARLES BRENT GANT provided a false name while lawfully detained by identifying himself as "Peter Hunter." Your Affiant explained to CHARLES BRENT GANT that he was under arrest and he continued to provide the false name.

During a search of CHARLES BRENT GANT'S person, your Affiant located a plastic bag containing the following items:

28 individual jeweler's bags, each containing approximately 1 gram of suspected marijuana. The suspected marijuana was field-tested and rendered a presumptive positive response for the presence of THC.

7 individually wrapped bags, each containing approximately 1 gram of suspected cocaine. The suspected cocaine was field-tested and rendered a presumptive positive response for the presence of cocaine.

5 individually wrapped bags, each containing approximately 1 gram of suspected MDPV. The suspected MDPV was field-tested and rendered a presumptive positive response for the presence of MDPV-Methylone.

Based upon your Affiant's training and experience, this amount of controlled substances and the method of packaging is consistent with a person involved in the distribution of controlled substances and not personal use.

Based upon your Affiant's investigation, there is probable cause to believe the Defendant, CHARLES BRENT GANT, did violate F.S.S. 893.13 (1a1) Possession of Cocaine with Intent to Distribute, F.S.S. 893.13 (1a2) Possession of Marijuana with Intent to Distribute, F.S.S. 893.13 (1a2) Possession of MDPV-Methylone with Intent to Distribute, F.S.S. 843.02 Resisting Officer without Violence, and F.S.S. 901.36 (1) Providing False Name While Lawfully Detained. These offenses are contrary to law, as such case provided, and against the peace and dignity of the State of Florida.
